

Sanborn Elementary Title I Parent Engagement Plan

PART I. General Expectations

Sanborn agrees to implement the following statutory requirements:

- Consistent with section 1118, the school will work to ensure that the required campus Title I Parent Engagement Plan meet the requirements of section 1118(b) of the ESEA, and include as a component, a school-parent compact consistent with section 1118(d) of the ESEA.

E. the carrying out of other activities, such as those described in section 1118 of the ESEA.

PART II. Description of how Sanborn will implement the required components of the campus Title I Parent Engagement Plan.

1. Sanborn Elementary will take the following actions to involve parents in the joint development of its campus Parent Engagement Plan under section 1112 of the ESEA:

- Establish the campus Parent Engagement Advisory Council adequately represented by parents of attending children, administrators and Title I personnel. Other council members may include community members and students.
- Annually hold a meeting to review, discuss, and revise the school's Title I Parent Engagement Plan.
 - We will invite a primary and an intermediate parent to participate on our Campus Parent Engagement Advisory Council. We will also include a community member who has a direct interest in the school and is familiar with the neighborhood and history of Sanborn. Prior to reviewing, discussing, and amending our plan we will provide training on what Title I entails and the importance of parent input.

2. Sanborn Elementary will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:

- Hold committee meetings, composed of parents and school staff, to review the Campus Improvement Plan.
 - We will invite a primary and an intermediate parent to participate on our Campus Parent Engagement Advisory Council. We will also include a community member who has a direct interest in the school and is familiar with the neighborhood and history of Sanborn. Prior to reviewing, discussing, and amending our plan we will provide training on what Title I entails and the importance of parent input.
- Provide Title I, Part A school staff support in enhancing their School Campus Improvement Plans.
 - Staff support training will be conducted during the August Professional Development days.
- Administer the Title I campus Parent Engagement Survey designed to identify the type of support, information, and resources that parents' need included in their Campus Improvement Plan and campus Parent Engagement Plan to better support their children's education and become more involved in their school.

3. Sanborn Elementary will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in the Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting and will encourage them to attend. These informative meetings may include, but are not limited to, the following:

- Sanborn will hold our Title I meeting on Open House Night, August 31, 2017. We will also have tables at registration with our Parent Engagement Plan in English and Spanish.

4. Sanborn Elementary, will, in a timely manner, provide parents of participating children information about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet:

- We will inform parents of these items during Open House Night, August 31, 2017 in English and Spanish.

5. Sanborn Elementary will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possibly.

These may include, but are not limited to, the following:

- Parents may access our website and submit emails directly to the principal, stop by the office and visit, or call our office with suggestions or comments. Parents may voice their need for trainings by our parent survey that will be conducted at registration. We have Spanish speakers in the office to meet the needs of our parents.

6. Sanborn Elementary will provide each parent a Skyward login and password to retrieve individualized student reports regarding the performance of their child on the state assessment in math, language arts and reading by:

- Sanborn had several opportunities for parents during the spring to come by and pick up Skyward logins and passwords. We did call outs and sent notes home to inform parents of our new online registration beginning in July. We will continue to provide times in July for parents to come by and pick up this information. Notes and callouts were done in English and Spanish.

7. Sanborn Elementary will provide assistance to parents of children served by the school, as appropriate, on important topics. These may include, but are not limited to, the following:

- Reviewing and understanding the state's academic content standards.
- Reviewing and understanding the state's student academic achievement standards.
- Reviewing and understanding the state and local academic assessments including alternative assessments.
- The requirements of Title I, Part A.
- How to monitor their child's academic progress.
- How to work with educators.
- Other topics that received strong parent interest as reflected by the Title I school Parent Engagement Survey.

8. Sanborn Elementary will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parent engagement. These may include, but are not limited to, the following:

- Library Night/Literacy Night
- Math Night
- Discovery Center Night
- Skyward Parent Training
- Parent engagement programs (e.g., Parenting Partners)

- Parents of students in bilingual classes will be informed in Spanish

9. Sanborn Elementary will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools. These efforts may include, but are not limited to, the following:

- We will evaluate the parent survey conducted at registration to determine how to best coordinate parent programs to involve parents as partners in the education of their children.

10. Sanborn Elementary will, to the extent feasible and appropriate, coordinate and integrate Title I parental engagement programs and activities with public preschool and other similar programs (e.g., Head Start, Parents as Teachers, etc.) that encourage and support parents in more fully participating in the education of their children. These efforts may include, but are not limited to, the following:

- We will send a letter in English and Spanish to welcome Head Start students to our campus.
- We have our parent liaison attend the Head Start roundup in April to provide parents information about Amarillo ISD upcoming events.

11. Sanborn Elementary will take the following actions to ensure that information related to the school, parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand. These may include, but are not limited to, the following:

- Most information sent to parents is translated into Spanish. Our callouts are conducted in English and Spanish. We provide a translator when we conduct parent meetings.

PART III. Discretionary Components of the Sanborn Elementary Title I Parent Engagement Plan

Sanborn Elementary may provide discretionary activities that build parents' capacity for engagement in Title I schools and the school system to support their children's academic achievement; these may include, but are not limited to, the following:

- Involving parents in the development of training for teachers, principals, and other educators to improve the effectiveness of that training.
- Providing necessary literacy training for parents from Title I, Part A funds, if the school district has exhausted all other reasonably available sources of funding for that training.
